Results

After completing this course, you will have:

- **technical understanding:** You will develop basic knowledge of AI concepts such as machine and deep learning, language models and prompting, so that you understand how AI systems work and what to expect from them.
- **ethical awareness:** We pay attention to ethical issues surrounding AI, such as bias and privacy, and the impact AI can have on individuals and communities.
- **legal knowledge:** You'll learn the nuances of relevant legislation such as the EU AI Act and the AVG, and how to meet compliance requirements.
- **practical skills:** The course provides hands-on experience with AI tools, so you can immediately apply theoretical knowledge in practice.
- **critical thinking skills:** Develop the ability to assess the impact of AI systems, identify risks and implement appropriate measures.
